

Privacy Policy

Scope and purposes of collection

LOMINI Ltd. can collect personal data of individuals in the following cases:

- Issuance of an invoice, warranty card or other document for sending ordered goods to customers or visiting by our technician;
- Receiving a quote, preparation of offer or purchase our products;
- Obtaining a CV and other documents necessary for participation in a recruitment procedure opened by LOMINI Ltd. and / or by the request of the individual;
- Preparing a work file for our employees.

LOMINI Ltd. processes personal data only for the following purposes:

- Legitimate business purposes of the company;
- Performing economic activity of LOMINI Ltd.;
- Signing and /or execution of a contract;
- Execution of liabilities of LOMINI Ltd. under the current labor, civil, tax, insurance and other legislation;
- Ensuring the safety and security of its employees and property;
- Prevention and / or investigation of incidents, violations and criminal offenses;
- Received approval when sending a request, etc..

Depending on the specific purpose, LOMINI Ltd. can process different data sets, such as:

- Names, addresses (for example issuance of invoice, warranty or carrier order)
- Contact details (address, phone, e-mail) - for correspondence, contract, other

- Education, qualifications, work history, professional experience, marital status, children;
- Health status: current health, general diseases, chronic diseases, etc.
- Judgment

LOMINI Ltd. keeps personal data within deadlines, according to the particular business purpose or purposes for which it has been collected and / or for the time specified by the law. Criteria for setting deadlines that are not legally regulated depend on:

- The purpose of collecting data and fulfillment of this purpose;
- Reason for data collection (until withdrawal of consent for processing).

Access to personal data

As a subject of personal data, you have the legal right to receive personal data that concern you and which are processed by us in a structured, widely used and machine-readable format, and you are entitled to transfer this data to another administrator, under certain by the law conditions. You can object to processing, request limitation of processing, or request addition, correction, or deletion of the data
